In addition to the reinstatement application fee, you will be required to pay the annual license fee of \$85 to return your license to active status. You may submit this fee with the application fee. One check is acceptable. The Board does not prorate this fee.

All NC geology licenses must be renewed by June 30 each year. Payment of the \$85 annual license fee and the completion of an additional 12 hours of Board-approved CE will be required in order to renew your license.

Any worker who is defined as an employee by N.C. Gen. Stat. §§ 95-25.2(4)(NC Department of Labor), 143-762(a)(3)(Employee Fair Classification Act), 96-1(b)(10)(Employment Security Act), 97-2(2)(Workers' Compensation Act), or 105-163.1(4)(Withholding; Estimated Income Tax for Individuals) shall be treated as an employee unless the individual is an independent contractor.
