Cancellation Policy:

- A \$25 administration cost per exam part will be incurred, for cancellation up to 30 calendar days prior to examination date.
- Examination fees will be forfeited when canceling within 30 calendar days of examination except as noted below.
- Examination fees, less a \$25 administration cost, per part of the exam, can be carried over to the next scheduled exam (one time only) per the applicant's request *before a deadline of 30 days prior to a pending examination*. No refunds will be made.
- Refunds for examination fees, less a \$25 administration cost per part of the exam (FG and PG), will be made upon applicant's furnishing satisfactory proof of extenuating circumstances within the 30 day period prior to a pending exam.
- Application fees will not be refunded

Applications to be considered must contain the following:

1. Signed and notarized application form and \$55 nonrefundable application fee.
2. Candidates for Part 1, Fundamentals of Geology will be qualified solely on the basis of meeting the necessary educational requirements (30 semester hours of undergraduate or graduate level courses).
 - Original Copy of Transcripts
3. Candidates for Part 2 Principals & Practice of Geology
 - (5) Professional reference forms. It is your responsibility to check with your references to verify that they have mailed them to us in time to meet the deadline. All references must be from licensed or qualified geologists or engineers. At least two of these references must be familiar with your work.
 - Equivalent of (5) years education and experience:
 - Undergraduate degree in Geology and (3) years experience
 - Graduate degree in Geology and (1) year experience.
 - Original copy of Transcripts.
 - Verification of experience.

DEADLINE TO MAKE APPLICATION IS DIFFERENT FROM DEADLINE TO ORDER EXAM

PLEASE NOTE: If you do not already have a complete, Board approved application on file with the Board, you are NOT eligible to order/take the ASBOG® exam. Deadline to make application to sit for the exam is one month prior to the Board meeting date. Applications for the August 11, 2022 Board meeting must be received by July 14, 2022 in order to be considered and approved to take the exam in October 2022.

The North Carolina Board for licensing of Geologists does not condone nor does it sponsor any of the Examination Study Sessions being offered to the public by individuals who are not associated with ASBOG or the North Carolina Board.

Incomplete Applications

- Applications which are not completed within one (1) calendar year of the initial date will be returned to the applicant, marked as "Incomplete". Prepaid examination fees will be refunded at that time, less a \$25 administration cost per part, and contents of the file on hand (references, etc.), will be placed on inactive status. No further contact by the Board will be made with the applicant, unless the applicant initiates a move to reactivate the file. Application fees will not be refunded.
