### Application to Change Business Name, Qualified Licensee Name or Address for NC Corporate Geological Certificate (No Fee), Order Replacement Wall Certificate (\$25), or Replacement Pocket License Card (\$10) for NC Geological Corporation

**Changing the Firm Name of a Corporate Certificate:** Before the NCBLG can change the name of the firm, the name of the firm must be properly changed with the NC Secretary of State's Office. Please submit a copy of the appropriate documentation with this application. A newly formed company must make application for a corporate license and must meet the requirements of NC GS§55B.

**Changing the Licensed Geologist in Charge of a Geological Corporation:** You may change the Licensee for your firm as long as the person is a properly NC Licensed Geologist, is a full time employee of the firm and is not the responsible geologist in charge for another firm. The licensee must meet the requirements of NC GS§55B. Documentation must be submitted with this form to certify that the licensee meets those requirements.

**Ordering a Wall Certificate and/or Pocket License Card:** You may order a wall certificate or pocket license only if your corporate certificate is in good standing and is properly renewed for the current license year. Submit \$25 for each wall certificate and \$10 for each pocket license. Make checks payable to the NCBLG and enclose with this form.
